

**THE MURANG'A COUNTY ALCOHOLIC DRINKS  
CONTROL (AMENDMENT) BILL, 2025**

**-A Bill for-**

**AN ACT of the County Assembly of Murang'a, to provide for  
the amendment of the Murang'a County Alcoholic Drinks  
Control Act, 2022 with regard to composition of the County  
Liquor Committee and composition of the Sub- county  
Committees and matters incidental thereto.**

**ENACTED** by the County Assembly of Murang'a, as follows-

This Act may be cited as the Murang'a County Alcoholic Drinks Control (Amendment) Act, 2025.	Short Title

1. Section 11 (2) of the Murang'a County Alcoholic Drinks Control Act, 2022 is amended to read as follows:	Amendment of composition of the Committee

The Committee shall consist of: —

- (a) County Executive Committee Member in charge of Health who shall be the co-chairperson;
- (b) the officer responsible for coordination of national government functions in the county;
- (c) County Chief Officer in charge of Health
- (d) The county chief officer in charge of revenue;
- (e) The county public health officer;
- (f) The officer commanding Kenya police services in the county;
- (g) The officer commanding administration police in the county;
- (h) The officer in charge of enforcement for the county government in the county;
- (i) The Director who shall be the secretary of the Committee and head of the alcoholic drinks control directorate;
- (j) The officer for the time being responsible for physical planning in the county;
- (k) two representatives from the cluster representing registered liquor dealers' association; and
- (l) ) two persons competitively recruited from among persons who are not public officers.

2. Section 13 (1) of the Murang'a County Alcoholic Drinks Control Act, 2022 is amended to read as follows:

Amendment of  
composition of  
the sub-county  
Committee

The sub-county committee shall consist of: —

- (a) Sub-county administrator who shall be the chairperson;
- (b) the officer responsible for coordination of national government functions in the sub-county;
- (c) The Subcounty coordinator of revenue;
- (d) The sub-county public health officer;
- (e) The officer commanding Kenya police services in the Sub-county;
- (f) The officer commanding administration police in the Sub-county;
- (g) The officer in charge county government enforcement in the Subcounty;
- (h) One officer designated by the Directorate who shall be the secretary;
- (i) One officer for the time being responsible for physical planning in the sub-county;
- (j) Five residents of the sub county appointed by the county executive committee member in charge of health through a competitive process, given that they are public officers and not more than three persons shall be of the same gender;
- (k) Two persons representing the liquor dealers' association from the Subcounty.

#### **MEMORANDUM AND OBJECTS**

The Bill seeks for the amendment of the Murang'a County Alcoholic Drinks Control Act, 2022 with regard to composition of the County Liquor Committee and composition of the Subcounty Committees and matters incidental thereto.

This amendment bill is not a money bill.
